- 1. Chairman Frederick called the meeting to order at 9:05 AM.
- 2. Discussion/Action on August 13, 2020 Minutes: James Lyman moved to approve as read, Chairman Frederick seconded. All in favor.
- 3. Discussion/Action on the abatement application of Alphonso Dixon, Jr at Map 19 Lot 38-2, 72 Smithfield Rd. in the value of \$43900 and tax of \$581.68: James Lyman moved to grant the abatement in the amount of \$581.68, Charlotte Curtis seconded. All in favor.
- 4. Discussion/Action on the abatement application of Anthony Frederick at Map 18 Lot 26-2, 546 Mercer Rd. in the value of \$25000 and tax of \$331.25 because he did not receive the Homestead Exemption: Chairman Frederick abstained because he is related to the applicant. Charlotte Curtis moved to grant the abatement in the amount of \$331.25, James Lyman seconded. 2-0 in favor.
