# 1. Call to Order

The meeting was called to order at 6:00 PM by Chairman Everett.

# 3. Review/Approve Minutes of March 17, 2021

Vice Chairman Lyman made a MOTION to approve the minutes of March 17, 2021. Seconded by Selectman Lynch. MOTION PASSED.

# 4. Selectmen's Reports

Selectman Frederick asked if the Town had any plans for Corporal Cole Day. The Town Manager stated that there was a multi-day roadside cleanup event and that provided an opportunity for folks in the community to volunteer and give back. It also ties in well with Earth Day.

Vice Chairman Lyman expressed concern about the impact of using salt and sand on sidewalks and then blowing those materials on front lawns throughout the downtown. The Town Manager will monitor the situation and work to address the concern moving forward.

## 6. Discussion/Action on April 7, 2021 General Warrant #7

Vice Chairman Lyman made a MOTION to approve General Warrant #7 in the amount of \$86,240.19. Seconded by Selectman Lynch. MOTION PASSED.

# 8. Discussion/Action on 2021 Road Projects, Pricing

Vice Chairman Lyman made a MOTION to accept the proposal from Pike Industries for the overlay and shoulder gravel project at a per ton rate of \$73.96 and gravel per cubic yard of \$36.00. Seconded by Selectman Lynch. MOTION PASSED.

Selectman Lynch made a MOTION to accept the proposal from Fine Line Paving in the lump sum amount of \$11,775.00 for crack hilling on Wilder Hill, Ward Hill, and Beech Hill Roads. Seconded by Selectman Curtis. MOTION PASSED. Selectman Lynch made a MOTION to accept the proposal from Fine Line Paving in at a per ton amount of \$165.00 for sidewalks shim/overlay and curb repair. Seconded by Selectman Curtis. MOTION PASSED.

## 9. Discussion/Action on Depot Street Traffic/Pedestrian Safety

The Board reviewed correspondence received from New Balance regarding safety concerns on Depot Street, as well as potential solutions.

Chairman Everett stated his support for temporary speed bumps on Depot Street to deter drivers.

Selectman Lynch inquired about the traffic lights at the intersection of Routes 2 and 201-A and the timing. She believes the lights are causing people to use Depot Street as a bypass.

Vice Chairman Lyman made a MOTION to authorize up to \$4,000 for the purchase of one temporary speed table for use on Depot Street, and associated signage. Seconded by Selectman Lynch. MOTION PASSED.

## 10. Discussion/Action on TIF Committee Recommendation—Landscape Design of Emery Town Square

The Board reviewed the memo sent on behalf of the TIF Committee and had a discussion regarding potential improvements to Emery Town Square. Becky Ketchum and Ruth Keister spoke on the issue, as they are both members of the TIF Committee.

Resident and pilot Ken Morgan spoke regarding what opportunities may available at the airport and also discussed the many things that are already going on out there. Mr. Morgan

notes that the airport's pilots are well-served, but there are significant opportunities for the airport to better serve members of the general public.

# 11. Discussion/Action on Selectmen Goals and Vision

Selectman Lynch:

- Maintenance ordinance: Disappointed with the results of the town meeting vote, she believes it is still imperative to work to improve the appearance of the downtown. Community center: In close proximity to trails and sports fields, the center could bring added economic value to the area and provide a potential revenue stream
- Multi-use trail system: The Town must position itself in a way that allows itself to serve as a hub along the trail corridor.

Vice Chairman Lyman:

• Multi-use trail system: It is important to position the community as a destination along the trail. It will be important that the Town have adequate, accessible parking for people who will be using these trails. Also, the Town must work to identify business opportunities that may support the trail system.

Selectman Curtis:

• Maintaining a small, rural town: How can the Town make money, but maintain its rural pastime?

Selectman Frederick:

- Maintain a small-town: How can the Town progress and still be a small town?
- Maximize value of taxpayer dollars: Make the best use of taxpayer money and run the Town the best it can be

Chairman Everett:

- Multi-use trail system: The Town must prepare for the trail development and also work to capitalize on economic opportunities.
- Improve ATV, ITS trails: The condition of these trail systems could use improvement and provide an opportunity for economic development. Can the Town serve as a resource to earn grant money to fund these improvements?
- Installation of security cameras in public areas (i.e., Oosoola Park, downtown, etc.)
- Food pantry: There is an obvious need for improvement. The Town can take the lead or serve as a partner in this venture. Access to food continues to be a concern in the community.
- Electronic message board: Second sign installation at Hatfield Athletic Park
- Fire hydrants: Hydrants need to be painted.
