### 6. Discussion/Action on April 3, 2024 General Warrant 2024-06

Ms. Lynch made a MOTION to approve and sign General Warrant 2024-06 in the amount of \$31,533.00. Seconded by Mr. Blodgett. MOTION PASSED.

# 8. Presentation by Somerset Economic Development Corporation Regarding the Somerset Broadband Coalition

Somerset Economic Development Corporation (SEDC) Executive Director Christian Savage provided an update to the Board regarding the broadband coalition. The program organizes technology and technology services in the community and they are looking to cooperate with the Town and the library. Mr. Savage also provided a brief update on broadband in the area. The Town of Norridgewock contributed \$3,200 in TIF funds towards the project in May 2021. That investment provided substantial market information that the SEDC could leverage to spur private investment in

broadband throughout the region. It is estimated that nearly 98% of the County will benefit from broadband access due to the County's work with the Town's support.

### 9. Discussion/Action on TIF Committee Recommendations

Ms. Lynch made a MOTION to accept the TIF Advisory Committee's recommendation and approve the proposed agreement between the Town of Norridgewock and Somerset Economic Development Corporation, authorizing \$100,000 in a revolving loan fund. Seconded by Mr. Blodgett. MOTION PASSED.

### 10. Discussion/Action on Fire Department Capital List

Fire Chief Todd Pineo presented the Board with an updated version of the Department's capital list. He reviewed the items included and the justification for the prioritization. The review also incorporated a review of potential funding mechanisms for each project. Chief Pineo also reviewed a presentation regarding the proposed purchase of a side-by-side and enclosed trailer that will upgrade the existing ATV and flatbed trailer to help the Department respond, especially regarding the rail trail.

### 11. Discussion/Action on Wade Street Property Demolition & Cleanup Proposals

Ms. Lynch made a MOTION to accept the proposal from DMO Landscaping, Inc. in the amount of \$8,300.00 for the property cleanup, plus an additional \$500.00 for removing the two trees. Seconded by Ms. Goodrich. MOTION PASSED.

Ms. Lynch made a MOTION to appoint Brandi Ireland to the Tax Increment Financing Advisory Committee for a term of three years. Seconded by Mr. Blodgett. MOTION PASSED.

Ms. Lynch made a MOTION to appoint Jeffrey McGown to the Norridgewock Water District Board of Trustees for a term of three years. Seconded by Mr. Blodgett. MOTION PASSED.
